Emissions reduction targets

In order to continue our progress to achieving Net Zero, we have adopted the following carbon reduction targets. We project that carbon emissions will decrease over the next five years to 400 tCO2e by 2029. This is a reduction of approximately 38% from our baseline.

Carbon Reduction Projects

Completed Carbon Reduction Initiatives:

The following environmental management measures and projects have been completed or implemented since the 2023 baseline. The carbon emission reduction achieved by these schemes equates to 60 tCO2e, a 9.2% reduction against the 2023 baseline.

1. Energy Efficiency:

- Upgrade to energy-efficient lighting and appliances.
- o Implementation of energy management systems in all facilities.

2. Renewable Energy:

- Transition to 100% renewable energy sources for all operations.
- Installation of solar panels at the Hampshire and Weston Super Mare operational hubs.

3. Transportation:

- Transition to a fleet of electric and hybrid vehicles.
- Optimisation of route planning to reduce fuel consumption.

4. Waste Management:

- Implementation of comprehensive recycling programs.
- Reduction of waste generation through digital documentation and other initiatives.

5. Employee Engagement:

- Provision of training on sustainable practices.
- Encouragement of remote working to reduce commute-related emissions.

6. Supply Chain:

- Partnership with suppliers committed to reducing their carbon footprint.
- Evaluation and selection of suppliers based on their sustainability practices.

Future Carbon Reduction Projects

In the future, we hope to implement further measures such as:

- 1. Advanced Renewable Energy Projects:
 - Expanding solar energy installations to more operational hubs.
 - Investing in wind energy partnerships.
- 2. Innovative Waste Reduction Techniques:
 - o Introduction of zero-waste policies across all departments.
 - Collaboration with waste-to-energy facilities.
- 3. Enhanced Transportation Solutions:
 - Further expansion of electric vehicle fleet.
 - Implementation of AI-driven route optimisation.
